Mr. Forsythe presented Local Law No. 1 for the Year 1964 as follows:

A LOCAL LAW, COUNTY OF LIVINGSTON, PROVIDING SALARY  
INCREASES FOR CERTAIN COUNTY OFFICERS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LIVINGSTON AS FOLLOWS:

Section 1. Effective as hereinafter provided, the total increment of the County Treasurer shall be increased by \$300.

Section 2. Effective as hereinafter provided, the total increment of the County Clerk shall be increased by \$300.

Section 3. Effective as hereinafter provided, the total increment of the County Attorney shall be increased by \$200.

Section 4. Effective as hereinafter provided, the minimum and maximum salaries of three (3) Commissioners of Civil Service shall be increased by \$50.

Section 5. Effective as hereinafter provided, the minimum and maximum salary of the Commissioner of Elections, Robert Prescott, shall be increased by \$75.

Section 6. Effective as hereinafter provided, the total increment of the Sheriff shall be increased by \$300.

Section 7. This Local Law shall take effect on January 1, 1965.

RESOLUTION PROVIDING FOR PUBLIC HEARING ON PROPOSED LOCAL LAW
