Mr. Roeser presented Local Law No. 2 for 1969 as follows:

LOCAL LAW NO. 2, 1969, COUNTY OF LIVINGSTON, PROVIDING  
SALARY INCREASES FOR CERTAIN COUNTY OFFICERS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY  
OF LIVINGSTON AS FOLLOWS:

Section 1. Effective as hereinafter provided, the annual salary of the County Judge and Surrogate and Family Court Judge shall be increased by \$2,500.

Section 2. Effective as hereinafter provided, the annual salaries of the two (2) Commissioners of Elections shall be increased by \$254 each.

Section 3. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$3,935., \$2,850. of which is in lieu of maintenance previously furnished.

Section 4. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$1,186.

Section 5. Effective as hereinafter provided, the annual salaries of the three (3) Commissioners of Civil Service shall be increased by \$36 each.

Section 6. Effective as hereinafter provided, the annual salary of the Indigent Defendant Administrator shall be increased by \$183.

Section 7. This Local Law shall take effect January 1, 1970.
