LOCAL LAW NO. 1, 1974, COUNTY OF LIVINGSTON,
PROVIDING SALARY INCREASES FOR CERTAIN
COUNTY OFFICERS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LIVINGSTON AS FOLLOWS:

Section 1, Effective as hereinafter provided, the annual salary of the District Attorney shall be increased by \$922.

Section 2, Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$500.

Section 3, Effective as hereinafter provided, the annual salary of the Assistant Director of Real Property Tax Services shall be increased by \$400.

Section 4, Effective as hereinafter provided, the annual salary of the County Historian shall be increased by \$100.

Section 5, Effective as hereinafter provided, the annual salary of the Director of Civil Defense and Fire Co-Ordinator shall be increased by \$300.

Section 6, Effective as hereinafter provided, the annual salary of the County Sealer of Weights and Measures shall be increased by \$450.

Section 7, Effective as hereinafter provided, the annual salary of the Acting Commissioner of Public Health shall be increased by \$300.

Section 8, Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$600.

Section 9, Effective as hereinafter provided, the annual salary of the Dog Warden shall be increased by \$520.

Section 10, Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$700.

Section 11, All salaries set forth herein shall be retroactive to January 1, 1974.

Section 12, This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.

Section 13, This Local Law is subject to Permissive Referendum.


