Section 1. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$500.00.

Section 2. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$500.00.

Section 3. Effective as hereinafter provided, the annual salary of the Director of Veterans Services shall be increased by \$1,000.00.

Section 4. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$900.00

Section 5. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$500.00.

Section 6. All salaries set forth herein shall be retroactive to January 1, 1975.

Section 7. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.

Section 8. This Local Law is subject to a permissive referendum.




