A local law Providing Salary Increases for Certain County Officers

**BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LIVINGSTON,
AS FOLLOWS:**

- Section 1. Effective as hereinafter provided, the annual salary of the (2) County Judges shall be increased by \$1,000. each.
- Section 2. Effective as hereinafter provided, the annual salary of the Indigent Defender Administrator shall be increased by \$140.
- Section 3. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,200.
- Section 4. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$700.
- Section 5. Effective as hereinafter provided, the annual salary of the three (3) Commissioners of Civil Service shall be increased by \$25. each.
- Section 6. Effective as hereinafter provided, the annual salary of the County Historian shall be increased by \$265.
- Section 7. Effective as hereinafter provided, the annual salary of the two (2) Commissioners of Elections shall be increased by \$255. each.
- Section 8. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$3,000.
- Section 9. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$970.
- Section 10. Effective as hereinafter provided, the annual salary of the Director, Real Property Tax Services shall be increased by \$560.
- Section 11. Effective as hereinafter provided, the annual salary of the Director of Veterans Services shall be increased by \$800.
- Section 12. Effective as hereinafter provided, the annual salary of the Director of Civil Defense and Fire Coordinator shall be increased by \$220.
- Section 13. Effective as hereinafter provided, the annual salary of the County Sealer of Weights and Measures shall be increased by \$500.
- Section 14. Effective as hereinafter provided, the annual salary of the Dog Warden shall be increased by \$580.
- Section 15. All salaries set forth herein shall be retroactive to January 1, 1977.
- Section 16. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.
- Section 17. This Local Law is subject to permissive referendum.

(City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. of 19..... of the City of..... having been submitted to referendum pursuant to the provisions of § 36 § 37 of the Municipal Home Rule Law and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special general election held on 19 became operative.

I hereby certify that the local law annexed hereto, designated as Local Law No. of 197 of the County of State of New York, having been submitted to the Electors at the General Election of November 19, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
