Section 1. *Effective as hereinafter provided, the annual salary of the three (3) Commissioners of Civil Service shall be increased by \$50.00 each.*

Section 2. *Effective as hereinafter provided, the annual salary of the two (2) Commissioners of Elections shall be increased by \$400.00 each.*

Section 3. *Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$1,600.00.*

Section 4. *Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$1,500.00.*

Section 5. *Effective as hereinafter provided, the annual salary of the Director, Real Property Tax Services shall be increased by \$910.00.*

Section 6. *Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$1,300.00*

Section 7. *All salaries set forth herein shall be effective as of January 1, 1979.*

Section 8. *This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.*

Section 9. *This Local Law is subject to permissive referendum.*
