Section 1. Effective as hereinafter provided, the annual salary of the Chairman of the Board of Supervisors shall be increased by \$920.00.

Section 2. Effective as hereinafter provided, the annual salary of the Board of Supervisors shall be increased by \$400.00.

Section 3. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$4,750.00.

Section 4. Effective as hereinafter provided, the annual salary of the two Commissioners of Elections shall be increased by \$600.00.

Section 5. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,700.00.

Section 6. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$1,600.00.

Section 7. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,925.00.

Section 8. Effective as hereinafter provided, the annual salary of the County Administrator shall be increased by \$5,125.00.

Section 9. Effective as hereinafter provided, the annual salary of the County Highway Superintendent shall be increased by \$2,175.00.

Section 10. Effective as hereinafter provided, the annual salary of the County Auditor shall be increased by \$1,400.00.

Section 11. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$4,200.00.

Section 12. All salaries set forth herein shall be effective as of January 1, 1991.
