- Section 1. *Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,400.00.*
- Section 2. *Effective as hereinafter provided, the annual salary of the two (2) Commissioners of Elections shall be increased by \$600.00 each.*
- Section 3. *Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,850.00.*
- Section 4. *Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$2,300.00.*
- Section 5. *Effective as hereinafter provided, the annual salary of the Livingston County Attorney shall be increased by \$1,900.00.*
- Section 6. *Effective as hereinafter provided, the annual salary of the Director, Real Property Tax Services shall be increased by \$1,600.00.*
- Section 7. *Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$2,000.00.*
- Section 8. *All salaries set forth herein shall be effective as of January 1, 1983.*
- Section 9. *This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.*
- Section 10. *This Local Law is subject to permissive referendum.*
