Be it enacted by the Board of Supervisors of the

- SECTION 1. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,175.00
- SECTION 2. Effective as hereinafter provided, the annual salary of the two (2) Commissioners of Elections shall be increased by \$500.00 each.
- SECTION 3. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,375.00.
- SECTION 4. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$1,925.00.
- SECTION 5. Effective as hereinafter provided, the annual salary of the Livingston County Attorney shall be increased by \$375.00.
- SECTION 6. Effective as hereinafter provided, the annual salary of the Director, Real Property Tax Services shall be increased by \$1,325.00.
- SECTION 7. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,700.00.
- SECTION 8. All salaries set forth herein shall be effective as of January 1, 1985.
- SECTION 9. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.
- SECTION 10. This Local Law is subject to permissive referendum.
