Local Law No. 3 of the year 19 85

A local law to provide for adjustment of veterans exemption to maintain ratio after changes due to full value assessment.

Be it enacted by the Board of Supervisors of the

County
City of Livingston, State of New York
Town
Village as follows:

SECTION 1. Pursuant to Subdivision 5 Paragraph (a) of Section 458 of the Real Property Tax Law, the County of Livingston hereby provides that inasmuch as the assessed value of real property in the tax district has heretofore been increased or decreased due to a full value assessment in the tax district, the amount of exemption heretofore or hereafter granted pursuant to Section 458 of the Real Property Tax Law shall be increased or decreased in such subsequent years in the same proportion as the total assessed value has been increased or decreased. Such adjustment shall be made by the assessors in the manner provided in Subdivision 1 Paragraph 3 of Section 458 of the Real Property Tax Law and no application therefore need be filed by or on behalf of any owner of any eligible property.

SECTION 2. Any local law, ordinance, resolution or other act to the extent inconsistent herewith shall be superseded by this local law.

SECTION 3. This Local Law shall become effective upon the date it is filed in the office of the Secretary of State.
