Local Law No. 1 of the year 19 88

A local law Providing for Salary Increases for Certain County Officers

Be it enacted by the Board of Supervisors of the

County of Livingston as follows:

- SECTION 1. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,850.00.
SECTION 2. Effective as hereinafter provided, the annual salary of the two (2) Commissioners of Elections shall be increased by \$550.00 each.
SECTION 3. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,575.00.
SECTION 4. Effective as hereinafter provided, the annual salary of the County Superintendent of Highways shall be increased by \$2,075.00.
SECTION 5. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$2,075.00.
SECTION 6. All salaries set forth herein shall be effective as of January 1, 1988.
SECTION 7. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.
SECTION 8. This Local Law is subject to permissive referendum.


