LOCAL LAW NO. 1 - 1990 COUNTY OF LIVINGSTON PROVIDING FOR SALARY INCREASES FOR CERTAIN COUNTY OFFICERS

BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LIVINGSTON AS FOLLOWS:

Section 1. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$2,000.00.

Section 2. Effective as hereinafter provided, the annual salary of the two Commissioners of Elections shall be increased by \$600.00 each.

Section 3. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,600.00.

Section 4. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$1,600.00.

Section 5. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,850.00.

Section 6. Effective as hereinafter provided, the annual salary of the County Administrator shall be increased by \$2,500.00.

Section 7. Effective as hereinafter provided, the annual salary of the County Highway Superintendent shall be increased by \$2,100.00.

Section 8. All salaries set forth herein shall be effective as of January 1, 1990.

Section 9. This Local Law shall take effect on the date of filing in the office of the Secretary of State of the State of New York.

Section 10. This Local Law is subject to permissive referendum.
