**Section 1.**

Section 3 of Local Law No. 2 - 1998 entitled "A Local Law Providing a Partial Exemption From Real Property Taxes to Persons with Disabilities Who Have Limited Income" is amended to read as follows:

**Section 3.**

To be eligible for the exemption authorized by Real Property Tax Law §459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$14,000.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

<u>ANNUAL INCOME</u>	<u>PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION</u>
More than \$14,000.00 but less than \$15,000.00	45 per centum
\$15,000.00 or more but less than \$16,000.00	40 per centum
\$16,000.00 or more but less than \$17,000.00	35 per centum
\$17,000.00 or more but less than \$17,900.00	30 per centum
\$17,900.00 or more but less than \$18,800.00	25 per centum
\$18,800.00 or more but less than \$19,700.00	20 per centum
\$19,700.00 or more but less than \$20,600.00	15 per centum
\$20,600.00 or more but less than \$21,500.00	10 per centum
\$21,500.00 or more but less than \$22,400.00	5 per centum
