A local law Delegating to the Sheriff of the County of Livingston the Power to Request and Grant Police Assistance Pursuant to Section 209-m of the General Municipal Law of the State of New York.

SECTION 1. Pursuant to section 209-m of the General Municipal Law of the State of New York, the powers granted to the Chairman of the Board, the chief executive officer of the County of Livingston, to request and grant police assistance from and to the police forces of other local governments within the County of Livingston whenever the public interest so requires is hereby delegated to the Livingston County Sheriff or his or her designees.

SECTION 2. Pursuant to section 209-m such delegated powers conferred on the Livingston County Sheriff shall include but not be limited to requesting the chief executive officer, or his or her designee, of any other local government whenever the public interest requires, to detail, assign and make available for duty and use by or in conjunction with the Livingston County Sheriff, any part of the forces, equipment and supplies of the police department or police force of such other local government.
