A local law of the Correction Law of the State of NY, for the Cost of Medical Care

Provided to Inmates in the Custody of the Livingston County Sheriff's Dept.

as follows:

SECTION 1. Pursuant to section 500-h (1) of the Correction Law of the State of New York, the County of Livingston is required to provide medical care to all inmates in the custody of the Livingston County Sheriff's Department without cost or charge to the inmates.

SECTION 2. Pursuant to the power granted under section 500-h (2) of the Correction Law of the State of New York, the County of Livingston is hereby authorized to seek reimbursement for costs paid pursuant to 500-h (1) of the Correction Law of the State of New York from any health insurance, third party coverage or indemnification carried by an inmate receiving medical care or treatment. Such health insurance, third party coverage or indemnification shall first be applied against the total cost to the health care provider as established in accordance with the provisions of section 2807 of the Public Health Law of the State of New York.




