SECTION 1. Pursuant to the authority granted by Section 252-a of the Family Court Act of the State of New York the Livingston County Department of Probation is hereby authorized to collect a fee for all investigations it is ordered to conduct pursuant to Section 653 of the Family Court Act of the State of New York. The fee will be collected from both parties to the proceeding, based upon their respective income, according to the following schedule:

<u>INCOME</u>	<u>FEE</u>
\$ 0 - \$15,000	\$ 50.00
\$15,000 - \$20,000	\$100.00
\$20,000 - \$30,000	\$200.00
over \$30,000	\$250.00

SECTION 2. The Livingston County Department of Probation is authorized to adopt procedures for the collection of these fees pursuant to guidelines issued by the Director of the Probation and Correctional Alternatives.

SECTION 3. The Family Court shall retain the authority to waive the fee if it determines a party lacks sufficient ability to pay.

SECTION 4. All fees collected pursuant to this Local Law shall be paid directly to the Livingston County Department of Probation to be retained and utilized for local probation purposes.

SECTION 5. This local law shall take effect upon filing with the Secretary of State.




