Section 1. Effective as hereinafter provided, the annual salary of the two Commissioners of Elections shall be increased by \$3,350.00.

Section 2. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$2,975.00.

Section 3. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$3,150.00.

Section 4. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$2,375.00.

Section 5. Effective as hereinafter provided, the annual salary of the Director of Personnel shall be increased by \$4,200.00.

Section 6. Effective as hereinafter provided, the annual salary of the Highway Superintendent shall be increased by \$1,775.00.

Section 7. Effective as hereinafter provided, the annual salary of the County Auditor shall be increased by \$1,975.00.

Section 8. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$1,600.00.

Section 9. All salaries set forth herein shall be effective as of January 1, 1995.

Section 10. This Local Law shall take effect on the date of filing in the Office of the Secretary of State of the State of New York.

Section 11. This Local Law is subject to permissive referendum.
