Section 1. The Livingston County Board of Supervisors hereby elects to provide all its eligible employees with a Retirement Incentive Program authorized by Chapter 12 of the Laws of 1995.

Section 2. The commencement date of the Retirement Incentive Program shall be October 1, 1995.

Section 3. The open period during which eligible employees may retire and receive the additional retirement benefit shall be 90 days in length.

Section 4. The actuarial present value of the additional retirement benefits payable pursuant to the provisions of this local law shall be paid as one lump sum or in five annual installments. The amount of the annual payment shall be determined by the Actuary of the New York State and Local Employees' Retirement System, and it shall be paid by the County of Livingston for each employee who receives the retirement benefits payable under this local law.

Section 5. This local law shall take effect upon it's filing with the Secretary of State and the New York State and Local Employees' Retirement System.


