A local law Providing a Partial Exemption from Real Property Taxes to Persons

Section 1.

This Local Law is adopted pursuant to the authority granted by Real Property Tax Law §459-c. All definitions, terms and conditions of such statute shall apply to this Local Law.

Section 2.

Real property owned by a person with disabilities whose income is limited by such disabilities, and used as the legal residence of such person, shall be entitled to a partial exemption from taxation to the extent of 50% of the assessed valuation.

Section 3.

To be eligible for the exemption authorized by Real Property Tax Law §459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$12,500.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

<u>ANNUAL INCOME</u>	<u>PERCENTAGE ASSESSED VALUATION EXEMPT FROM TAXATION</u>
More than \$12,500.00 but less than \$13,500.00	45 per centum
\$13,500.00 or more but less than \$14,500.00	40 per centum
\$14,500.00 or more but less than \$15,500.00	35 per centum
\$15,500.00 or more but less than \$16,400.00	30 per centum
\$16,400.00 or more but less than \$17,300.00	25 per centum
\$17,300.00 or more but less than \$18,200.00	20 per centum
\$18,200.00 or more but less than \$19,100.00	15 per centum
\$19,100.00 or more but less than \$20,000.00	10 per centum
\$20,000.00 or more but less than \$20,900.00	5 per centum
