Section 1:

The Board of Supervisors of Livingston County intends by this Local Law to supersede the provisions of County Law §215 (4) and §215 (6), which limit leases of County property to 5 year terms and only to the highest responsible bidders after public advertisement. The Board of Supervisors has determined that the lease of a parcel of property to Rochester Telephone Mobile Communications for the construction of a telecommunication tower should not be limited to a 5 year period nor is it appropriate to lease to the highest bidder after public advertisement.

Section 2:

The Livingston County Board of Supervisors hereby determines that it is in the best interest of the County of Livingston to supersede the provisions of §215 (4) and §215 (6) of the County Law and therefore authorizes the lease of a parcel of property to Rochester Telephone Mobile Communications for a period of 25 years. The terms of such lease shall nevertheless be subject to the prior approval of the Livingston County Board of Supervisors.
