Section 1: The definition of “Residential Unit” contained in **Section 2. Definitions** of Local Law No. 3 of 1972 entitled “County of Livingston, Establishing and Imposing Sewer Rents in the Conesus Lake County Sewer District, in accordance with the provisions of Article Fourteen -F of the General Municipal Law” is amended to read as follows:

Residential Unit: A residential unit shall consist of a residence containing separate living quarters, with separate plumbing, kitchen and toilet facilities, housing one or more persons, irrespective of whether or not such separate living quarters are part of what is commonly known as a two family or multiple dwelling unit. A residential unit shall include a home, cottage, trailer and apartment, whether occupied on a seasonal or yearly basis.

Section 2: This Local Law shall be effective November 1, 1998.


