Section 1: The Board of Supervisors of Livingston County intend by this local law to supercede the provisions of County Law § 215 (5) and § 215 (6), which limits sales of County real property to the highest responsible bidder after public advertisement.

Section 2: The County of Livingston, by resolution No. 2001-343, declared approximately 1½ acres of vacant land situate at Route 20A and Millennium Drive in the Village of Geneseo as surplus property.

Section 3: The County of Livingston is hereby authorized to sell said 1½ acres of vacant land at private sale to the Livingston County Chamber of Commerce for \$60,000.00.

Section 4: The final sales contract shall be subject to approval by the Livingston County Board of Supervisors by two-thirds majority vote.

Section 5: This local law is subject to a permissive referendum.

Section 6: This local law shall take effect on the date of filing with the Secretary of State of New York.
