Section 1:

Pursuant to and subject to the provisions Section 308-a of the County Law of the State of New York, the Livingston County Board of Supervisors hereby imposes a surcharge of thirty cents (30¢) per month on each wireless communication device, which surcharge shall be reflected and made payable on bills rendered for wireless communication service provided to customers whose place of primary use is within the County of Livingston.

Section 2:

Wireless Communication Service Suppliers shall begin to add the above mentioned surcharge to the billings of its customers on December 1, 2002.

Section 3:

This local law shall take effect upon its filing with the Secretary of State.




