Section 1.

Livingston County Local Law No. 6 of 1993, relating to the procedures for enforcing real property taxes becoming liens, is hereby repealed.

Section 2.

This Local Law, repealing Local Law No. 6 of 1993, shall take effect January 1, 2004. Taxes becoming liens on and after that date shall be enforced pursuant to the procedures set forth in Article 11 of New York State's **Real Property Tax Law**.

Section 3.

Transition Period.

- A. For purposes of the enforcement of taxes which shall have become liens prior to January 1, 2004, the provisions of Chapter 313 of the Laws of 1936, as amended by Chapter 503 of Laws of 1977, known as the Livingston County Tax Act, shall continue in effect, for a transition period of four years from the effective date of this local law.
- B. During such transition period, if a parcel is subject both to a lien or liens arising prior to January 1, 2004 and to a lien or liens arising on or after January 1, 2004, the procedures applicable to the enforcement of delinquent taxes shall depend upon the lien or liens upon which the enforcement proceeding is based.

Section 4.

That this Local Law shall take effect as set forth herein.




