Section 1. Purpose: The County of Livingston by Local Law No. 1 of the year 2003 adopted the procedures forth in Article 11 of the New York State Real Property Tax Law for the enforcement of tax liens arising on or after January 1, 2004.

Section 1110 of the New York State Real Property Tax Law prescribes a standard redemption period of two years after the lien date.

Section 1111 of the New York State Real Property Tax Law authorizes a tax district to adopt a local law extending the redemption period for residential or farm property, or both, to three or four years after the lien date.

The purpose of this local law is to extend the redemption period as authorized by law.

Section 2. Redemption Period: The County of Livingston hereby extends the redemption period for residential and farm property to three years after the lien date.

Section 3. Filing with State Board: A copy of this local law shall be filed with the New York State Board of Real Property Services within 30 days after its enactment.

Section 4. Effective Date: This local law shall take effect immediately upon its filing with the New York State Secretary of State.
