NOTICE OF ADOPTION OF LOCAL LAW**

**LOCAL LAW NO. E – 2005 SUPERSEDING COUNTY LAW §215 (4) AND §215 (6)
RELATING TO A LEASE OF COUNTY PROPERTY TO ROCHESTER GENESEE
REGIONAL TRANSPORTATION AUTHORITY**

Be it enacted by the Board of Supervisors of the County of Livingston as follows:

Section 1:

The Board of Supervisors of Livingston County intends by this Local Law to supersede the provisions of County Law §215 (4) and §215 (6), which limit leases of County property to 5 year terms and only to the highest responsible bidders after public advertisement. The Board of Supervisors has determined that the lease of a parcel of property to Rochester Genesee Regional Transportation Authority for the construction of a centralized transportation facility at the Hampton Corners Complex should not be limited to a 5 year period nor is it appropriate to lease to the highest bidder after public advertisement.

Section 2:

The Livingston County Board of Supervisors hereby determines that it is in the best interest of the County of Livingston to supersede the provisions of §215 (4) and §215 (6) of the County Law and therefore authorizes the lease of a parcel of property at the Hampton Corners Complex to Rochester Genesee Regional Transportation Authority for a period of up to 35 years. The terms of such lease shall nevertheless be subject to the prior approval of the Livingston County Board of Supervisors.

Section 3:

This Local Law is subject to a permissive referendum.

Section 4:

This Local Law should take effect on the date of filing in the Office of the Secretary of State of the State of New York.
