**Section 1.**

Section 3 of Local Law No. 2 – 1998 entitled “A Local Law Providing a Partial Exemption from Real Property Taxes to Persons with Disabilities who have Limited Income” is amended to read as follows:

Section 3.

To be eligible for the exemption authorized by Real Property Tax Law §459-c and implemented by this Local Law, the maximum income of such person shall not exceed \$19,500.00. Any such person having a higher income shall be eligible for an exemption in accordance with the following schedule:

| <u>ANNUAL INCOME</u>                            | <u>PERCENTAGE ASSESSED<br/>VALUATION EXEMPT FROM TAXATION</u> |
|---|---|
| More than \$19,500.00 but less than \$20,500.00 | 45 per centum   |
| \$20,500.00 or more but less than \$21,500.00   | 40 per centum   |
| \$21,500.00 or more but less than \$22,500.00   | 35 per centum   |
| \$22,500.00 or more but less than \$23,400.00   | 30 per centum   |
| \$23,400.00 or more but less than \$24,300.00   | 25 per centum   |
| \$24,300.00 or more but less than \$25,200.00   | 20 per centum   |
| \$25,200.00 or more but less than \$26,100.00   | 15 per centum   |
| \$26,100.00 or more but less than \$27,000.00   | 10 per centum   |
| \$27,000.00 or more but less than \$27,900.00   | 5 per centum  |

This Local Law shall take affect immediately upon its filing in the Office of the Secretary of State and be effective with the 2009 assessment roll.




