Section 1.  
Effective as hereinafter provided, the annual salary for each of the two Commissioners of Elections shall be increased by \$1,750.00.

Section 2.  
Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$2,075.00.

Section 3.  
Effective as hereinafter provided, the annual salary of the County Highway Superintendent shall be increased by \$2,650.00.

Section 4.  
Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$2,600.00.

Section 5.  
Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$2,750.00.

Section 6.  
Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$3,300.00.

Section 7.  
Effective as hereinafter provided, the annual salary of the County Auditor shall be increased by \$2,225.00.

Section 8.  
Effective as hereinafter provided, the annual salary of the Public Defender shall be increased by \$2,775.00.

Section 9.  
All salaries set forth herein shall be effective as of January 1, 2009.




