Section 1. Effective as hereinafter provided, the annual salary for each of the two Commissioners of Elections shall be increased by \$950.00.

Section 2. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$1,635.00.

Section 3. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$1,175.00.

Section 4. Effective as hereinafter provided, the annual salary of the County Clerk shall be increased by \$1,475.00.

Section 5. Effective as hereinafter provided, the annual salary of the County Highway Superintendent shall be increased by \$1,500.00.

Section 6. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$1,475.00.

Section 7. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$1,550.00.

Section 8. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$1,900.00.

Section 9. Effective as hereinafter provided, the annual salary of the County Auditor shall be increased by \$1,275.00.

Section 10. Effective as hereinafter provided, the annual salary of the Public Defender shall be increased by \$1,575.00.

Section 11. All salaries set forth herein shall be effective as of January 1, 2013.

Section 12. This Local Law shall take effect on the date of filing in the Office of the Secretary of State of the State of New York.

Section 13. This Local Law is subject to permissive referendum.


