BE IT ENACTED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF LIVINGSTON AS FOLLOWS:

- Section 1. Effective as hereinafter provided, the annual salary of the Commissioner of Social Services shall be increased by \$1,925.00.
- Section 2. Effective as hereinafter provided, the annual salary of the County Administrator shall be increased by \$5,000.00.
- Section 3. Effective as hereinafter provided, the annual salary of the County Attorney shall be increased by \$2,250.00.
- Section 4. Effective as hereinafter provided, the annual salary of the County Auditor shall be increased by \$1,500.00.
- Section 5. Effective as hereinafter provided, the annual salary of the County Highway Superintendent shall be increased by \$1,775.00.
- Section 6. Effective as hereinafter provided, the annual salary of the County Treasurer shall be increased by \$3,500.00.
- Section 7. Effective as hereinafter provided, the annual salary of the Personnel Officer shall be increased by \$3,100.00.
- Section 8. Effective as hereinafter provided, the annual salary of the Public Defender shall be increased by \$3,100.00.
- Section 9. Effective as hereinafter provided, the annual salary of the Public Health Director shall be increased by \$10,000.00.
- Section 10. Effective as hereinafter provided, the annual salary of the Director of Real Property Tax Services shall be increased by \$1,400.00.
- Section 11. Effective as hereinafter provided, the annual salary of the Sheriff shall be increased by \$1,800.00.
- Section 12. All salaries set forth herein shall be effective as of January 1, 2015.
- Section 13. This Local Law shall take effect on the date of filing in the Office of the Secretary of State of the State of New York.
- Section 14. This Local Law is subject to permissive referendum.
