


Planning Staff are Homelessness and Housing Task Force members and Continuum of Care members

Staff collaborated with non-profit and Human Service agencies to explore the feasibility of a supportive housing project to meet the needs of county residents and the homeless population.





Map of Land Banks in NYS






2023 Achievements

- Reviewed 109 County referrals. 64 referrals were returned for local option; 45 referrals were reviewed by the County Planning Board
- Revised the standard advisory comments for the County Planning Board review regarding solar laws and projects.
- Deployed iPads for County Planning Board member materials reference during meetings.





2023 Achievements


2023 Achievements

- Contracted with two snowmobile clubs - Caledonia Trailblazers Snowmobile Club and Hill & Valley Riders Snowmobile Club - for maintenance of the snowmobile trail network in the Towns of Caledonia, Leicester, Livonia, Springwater & York
- Administered and completed 2022-2023 NYS Snowmobile Grant-in-Aid contract (\$25,728.00) in partnership with the clubs


2023 Accomplishments



- Continue to process addressing forms and right-of-way naming forms as they are submitted

Geographic Information Systems (GIS)

2023 Accomplishments

- Led department transition from ArcGIS ArcMap to newer software, ArcGIS Pro
- Utilized ArcGIS online along with GeoCove to manage public facing and internal web maps and applications, including updating Light Up Livingston Broadband maps and data
- Provided technical mapping assistance to the AFBP regarding NYS Department of Agriculture & Markets 303(b) proposals
- Provided mapping assistance for County Departments such as Economic Development, Central Services, Sheriff's Department and District Attorney
- Created new County Planning Board zoning referral trigger maps for each Town and Village based off of new parcel data and criteria to upload to the County website
- Utilized GeoCove's services to create ESRI applications for Economic Development and the Department of Health, such as downtime inventories, LivWell and lead story maps
- Provided monthly mapping assistance for County Planning Board zoning referrals
- Provided mapping assistance to the Emergency Operations Center for the 2024 solar eclipse
